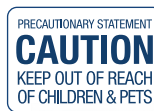

## Mixing/Dilution Directions

- 1) SHAKE container WELL prior to dilution process.
- 2) Prepare spray tank with required amount of water.
- 3) Blend in the product using the desired quantity (see mixing ratios below).
- 4) Mix solution well, until you achieve a homogenous aqueous solution.

## Crops

Successfully tested on: tomato, pepper, cucumber, eggplant, zucchini, squash, melon, watermelon, cauliflower, broccoli, cabbage, kale, citrus, pear, avocado, strawberry, raspberry, blackberry, blueberry, herbs and spices, roses, cut flowers, carrot, and more.

## Spraying

- 1) Use a high-quality sprayer to achieve a uniform fine mist. No need to remix diluted formula since it will remain homogenous and stable and will not separate.
- 2) Be sure spraying provides complete coverage of the plant's leaves and stems especially the underside of the leaves.

## Dipping

- 1) Mix the desired dosage with water in a suitable container.
- 2) Dip the entire plant or cutting, including the soil, in the solution for 15 seconds.

## USE RESTRICTIONS. DO NOT USE THIS PRODUCT WITH THE FOLLOWING CHEMICALS:

- Sulfur: Do not mix this product with sulfur or sulfur-containing products. Before using this product, make sure that spray tank and other equipment are free of sulfur residues. Do not apply sulfur within 10 days of an oil application, and do not apply oil within 14 days of an application.
- Do not use Captan or Folpet with or following use of this product.
- Do not use chlorothalonil (Bravo), dicloran (Botran), or permethrin (Ambush, Pounce) within 14 days before or after use of this product.
- Do not use chlorothalonil (Bravo) in a spray program with this product on grapes, ornamentals, or berries.
- Do not use dicofol (Kelthane) in a spray program with this product on ornamentals or berries.
- Do not use propargite (Omite) with this product or within 30 days before or after use of this product.
- Consult with your IMP Specialist or contact the manufacturer for guidance on the proper use of this in programs for resistance management and using it in an IPM program.

## Recommended Spray Time

Early AM or 3 hrs prior to sunset. Do not spray during high temperatures (above 85°F).
